

Washington County Economic Development Commission

July 13, 2017

The regular meeting of the Washington County Economic Development Commission (EDC) was held at 100 West Washington Street, Suite 1401. The following members were present: Julie Rohm (Chair), Gary Bockrath (Vice Chair), Hugh Breslin, Mike Fitzgerald, Jim Herbert, Andrew Lobley, Ed Lough, Joshua Martin, and Theresa Shank. Ex-Officio members in attendance included Emily Keller, Council Member for the City of Hagerstown, Jill Frick Thompson, Director of Community and Economic Development for the City of Hagerstown and the Honorable Gregory Snook, President of the Hagerstown/Washington County Industrial Foundation. Excused absence was Michael Reyka and Commissioner John Barr.

Call to Order - The meeting was called to order by Julie Rohm. Guest presenters in attendance included Wonro Lee, Joe Lee and Wook Lee of JG Business Link, Inc. (JGBLI).

Approval of the Agenda – Theresa Shank motioned to approve the Consent Agenda for July 13, 2017 as presented. The motion was seconded by Jim Herbert. The motion passed unanimously.

Approval of the Minutes – Joshua Martin motioned to approve the meeting minutes for May 11, 2017. The motion was seconded by Jim Herbert and approved unanimously. Andrew Lobley requested a statement referenced under New Business from the meeting minutes for June 8, 2017 be amended to "Pittsburgh Institute of Aeronautics hosts approximately 20-30 employers and invites City and County business representatives to meet with them to try to sway them to relocate to Washington County, MD." Mr. Lobley then motioned to approve the amended minutes, Hugh Breslin seconded the motion. The motion was unanimously approved.

Cascade Town Centre Update - Presented by Wonro, Joe, and Wook Lee of JG Business Link, Inc. (JGBLI).

- Development plans include a university system, with ties to the University of Maryland; programs under consideration include workforce development training, STEM, athletics, Asian medicines, hospitality, etc.; commercial/retail space; residential housing; Asian/American foods production and sales; and recreational facilities.
- History of Fort Ritchie will be preserved.
- Up to 3 million visitors per year is expected
- Total investment is estimated between \$1.5 to \$2B
- A trip to South Korea is planned for the Fall to meet with potential investors
